



Shariah Approval of "MUSKUN" Housing Finance Facility

For Property Purchase

Safar 07, 1437 A.H./ November 20, 2015

BankIslami's "MUSKUN" Housing Finance Facility has been developed under the principles of Shariah. All the principles and rules of Shirkat-ul-Milk are strictly adhered to.

This scheme has the following basic features:

- > MUSKUN will be made available to the Customer in different tenures.
- > BankIslami and the Customer will enter into 'Shirkat-ul-Milk Agreement' by virtue of which they will purchase a new property and will jointly hold share in the property in a specified ratio.
- > BankIslami's share in the property will be divided into units.
- BankIslami and the Customer will enter into **Payment Agreement**' under which the customer will make Monthly Payments to BankIslami for use of BankIslami's share in the property.
- > The amount of Monthly Payments to be made by the customer will be calculated according to a preagreed formula linked to a known benchmark.
- > Customer will undertake to buy BankIslami's units over the transaction tenure through Undertaking to Purchase Musharakah Units.
- > The Customer will undertake that in case he decides to purchase BankIslami's units earlier, he will purchase the units at a mutually agreed price.
- > Transaction agreements are also Shariah compliant.
